## APPLICATION FOR TEMPORARY PERMIT TO PRACTICE IN NEBRASKA

- **Application Fee: \$175.00**
- *This application is for those seeking a Temporary Permit to practice in geology in Nebraska who are not a resident of and do not have an established place of business in Nebraska.*
- **A temporary permit is issued for one specific project for up to one year.**
- **Temporary permits cannot be used to authorize organizations to practice or solicit to practice geology in Nebraska.**
- *A temporary permit will not be issued unless verification of good standing has been provided by the jurisdiction of your current license.*
- *It is the responsibility of the applicant to ensure all verifications and supporting documents are completed and received by the Board.*
- *Make checks payable to "Nebraska Board of Geologists" or "NEBOG". The application fee is nonrefundable once deposited by the Board. In the event your check is returned for insufficient or uncollected funds, we may re-present your check electronically. In the ordinary course of business your check will not be provided to you with your statement.*
